The bids received shall within the said time will be opened on 27.08.2018 at 3:30 P.M.

The sale will be governed by the following conditions: -

- I. The bidders are required to pay Earnest Money deposit of Rs. 2,000/- (Rupees Two thousand only) for the vehicle. EMD is to be submitted by sealed cover prominently super scribed with the words "EMD for condemned vehicle". The vehicle will be available for inspection between 13.08.2018 to 23.08.2018 at 11:00 A.M to 3:00 PM on all working day.
- II. Earnest Money is payable by means of Demand Draft drawn in favour of PPV&FR Authority, New Delhi (payment by cheque or cash shall not be accepted)
- III. Bids received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- IV. The successful bidder will be required to deposit the bid amount by way of Demand Draft drawn in favour of PPV&FR Authority, New Delhi within three working days of the acceptance of the bid.

- V. The Earnest Money of the successful bidder will be released only after the bidder deposits the sale proceeds. Earnest Money will not be adjusted as sale proceeds and will be forfeited if he fails to honour the bid.
- VI. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Voter Identity Card / Aadhar Card in case of individual and Registration Certificate in case of firms etc.)
- VII. The sold vehicle will be removed by the successful bidder within 48 hrs. of depositing the money, at their own expenses.
- VIII. The vehicle will be disposed of on "as is where is basis" and no guarantee for its worthiness or quality will be given by the Authority.
