- 3. The candidate intending to attend for interview, if any of his near or distant relative is an employee of the PPV&FR Authority, have to declare his/her name, designation, nature of duties, relationship in advance in writing during sending of the application form
- 4. Candidate will have to email the application in prescribed format only, scanned selfattested photocopies of all the required certificates/marksheet from secondary onwards, tabulated information of publications and experience certificates, if any. All original or provisional degree/mark sheets from Secondary examination onwards, Date of Birth

proof, UG/PG certificates/Grade cards/mark sheets, credentials, working experience, if any, will have to be produced by the successful candidate at the time of joining for verification, failing which, the offer of appointment will be deemed cancelled.

5. Last date for submission of application is 24th July, 2021.

- 6. The date of interview (on virtual mode) of the eligible candidates shall be communicated to the shortlisted candidates one week well in advance.
- 7. The posts are purely temporary and will be filled on contractual basis initially for one year which may be extended periodically subjected to performance or till the termination of the project.
