PUBLIC NOTICE (11 of 2021)

Sub: - Extension of time limit under PPV&FR Act, 2001 – Order dated 27th April, 2021 of Hon'ble Supreme Court of India in In Re Cognizance for Extension of Limitation in Suo Motu Writ Petition (C) No.3 of 2020.

By Public Notice 6 of 2020, the time limits for various proceedings under PPV&FR Act, 2001 was extended from 15.03.2020 till 14.03.2021 based on the order dated 8th March, 2021 of the Hon'ble Supreme Court in the above matter. Further, the Hon'ble Supreme Court vide order dated 27th April, 2021 in the same matter has directed that the period(s) of limitation, as prescribed under any general or special laws in respect of all judicial or quasi-judicial proceedings whether condonable or not, shall stand further extended from 15.03.2020 till further orders from the Hon'ble Supreme Court. Accordingly, Public Notice No.6 of 2021 stand revoked *in toto* and as per the said order of the Hon'ble Apex Court the time limit granted for various proceedings under PPV&FR Act, 2001 stands further extended from 15.03.2020 till further orders from the Hon'ble Supreme Court as hereunder: -
